- 1. When used in conjunction with an approved steel bulkhead.
- Consisting of: steel bulkhead insulated on stiffened side with 'SeaRox SL 618NA' (76mm thick, 96kg/m³ density) applied between the stiffeners and retained by steel pins and washers at maximum 305mm x 305mm centres. An additional layer of 'SeaRox SL 618NA' (38mm thick, 96kg/m³ density) is applied over the stiffeners and retained by steel pins and washers at maximum 305mm centres.
- 3. Composition and application of insulation material to be maintained in production and use in accordance with originally tested composition formula and method of application, and manufacturer's instructions.
- 4. Production items are to be manufactured in accordance with a quality control system which shall be maintained to ensure that items are of the same standard as the approved prototype.
