- 1. When used in conjunction with an approved steel deck.
- 2. Consisting of: steel deck insulated on underside with 'SeaRox FSL 618NA' (38mm thick, 96kg/m³ density) applied around the stiffeners and retained by steel pins and washers at maximum 355mm centres. An additional layer of 'SeaRox SL 618NA' (50mm thick, 96kg/m³ density) is applied between the stiffeners and retained by steel pins and washers at maximum 305mm x 355mm centres.
- Composition and application of insulation material to be maintained in production and use in accordance with originally tested composition formula and method of application, and manufacturer's instructions.
- 4. Production items are to be manufactured in accordance with a quality control system which shall be maintained to ensure that items are of the same standard as the approved prototype.
