"Steel Bulkhead A60 with steel plate: SeaRox FB or FM 6020 or SeaRox FB or FM 6040, stiffeners: SeaRox FM 6040, SeaRox FB or FM 6050"

Is composed of steel bulkhead to be insulated with one of the following variants:

- SeaRox FB or FM 6020 (density 40 kg/m³, minimum thickness 70 mm) between the stiffeners and SeaRox FM 6040 (density 60 kg/m³, minimum thickness 35 mm) around the stiffener.
- SeaRox FB or FM 6020 (density 40 kg/m³, minimum thickness 70mm) between the stiffeners and SeaRox FB or FM 6050 (density 70 kg/m³, minimum thickness 30 mm) around the stiffener.
- SeaRox FM 6040 (density 60 kg/m³, minimum thickness 35 mm) between the stiffeners and SeaRox FM 6040 (density 60 kg/m³, minimum thickness 35 mm) between and around the stiffener.

#### For all variants:

- The insulation is fixed to the bulkhead by means of standard Ø3mm pins in combination with 30-38 diameter steel clips (spring washers).
- Distance between pins on the stiffeners is maximum 300 mm. Distance between pins on the bulkhead (between stiffeners) is maximum 300 mm.

For further details about pin-settings and design see drawings listed under Type Examination documentation below.

# Application/Limitation

Approved for use as a vertical fire retarding division of class A-60. Restricted application; Fire against insulated side.

The insulation materials and adhesives used have to be approved according to the Marine Equipment Directive and bear the Mark of Conformity. This requirement may also be applicable for surface materials used, if required by relevant rules and regulations.

Each product is to be supplied with its manual for installation, use and maintenance.
