## **Product description**

"A-15 Steel Bulkhead with SeaRox FB 6040 35 mm or SeaRox FM 6040 35 mm"

Composed of structural steel bulkhead insulated with one layer (35 mm thick) of mineral wool designated SeaRox FB 6040 or SeaRox FM 6040, with a nominal density of 60 kg/m³ (manufactured by Rockwool International A/S) between stiffeners.

The insulation is fixed on the unexposed side by  $\emptyset$  3 mm steel pins with  $\emptyset$  30 - 38 mm washers. Maximum distance between pins is 300 mm.

For further details, see drawings listed under Type Examination documentation below.

#### Application/Limitation

Approved for use as a vertical fire retarding division of class A-15.

The insulation materials and adhesives used have to be approved according to the Marine Equipment Regulation and bear the Mark of Conformity. This requirement may also be applicable for surface materials used, if required by relevant rules and regulations.

Each product is to be supplied with its manual for installation, use and maintenance.
